



## "We want your input!" OPEN HOUSE/PUBLIC HEARING

The project team has completed the technical analysis on two design alternatives in the draft Environmental Impact Statement (EIS), which also considered a "no action" alternative. The analysis evaluated how the alternatives would affect a variety of community and environmental resources. Paid for by the legislature with Connecting Washington funds, the Industrial Way/Oregon Way Intersection Project will develop an affordable long-term roadway solution to improve travel reliability for all vehicles, accommodate current and future freight truck and passenger vehicle movement, and maintain or improve emergency response at this critical intersection.



At this open house/public hearing, you are invited to discuss the project and its draft EIS (published on March 2, 2018) with the project team. Attendees

are encouraged to provide feedback on the alternatives. Your participation is an important step in the process and are strongly encouraged to provide comments on what you like and do not like about the alternatives, whether they meet the needs of your community, and the findings contained in the draft EIS. Your feedback will be considered, along with other technical information, by the project's Executive Committee to identify the preferred alternative. Comments may be written or provided to a court reporter at the hearing.
